**DIRECTIONS TO THE TRIAL**

**From North-bound I81:** Take **Exit 5** off of **I-81** in Binghamton, NY. Turn right at the top of the ramp. Follow this road (US 11) to the third light. Turn left onto North Campus Drive. There is a Starbucks Coffee at this light. The Ice Center is the last building on the left.

**From South-bound I81:** Take **Exit 6** off of **I-81** in Binghamton, NY. AT bottom of ramp, turn left. At first intersection turn right. Follow this road (US 12) to the site. Turn right onto North Campus Drive. There is a Starbucks Coffee at this light. The Ice Center is the last building on the left.

**No entry fee will be refunded** in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Show Committee.

**Bitches in season.** A refund of entry fees will be given for bitches in season, less a \$5 processing fee. A letter from a veterinarian must be included with the request and must be received by the Trial Secretary no later than ½ hour before the start of the trial.

**Duplicate Entries.** Every effort to find duplicate entries will be made; however, after entries close, no refund will be made.

**Errors on Entry Blanks.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**Each Owner and Agent** listed on the entry form and/or individual responsible for the dog at a show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed and submitted the entry form

**As specified in Chapter 12, Section 4** of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

**The Trial Will Be Open** from 7:00 am until 30 minutes after the trial is completed. Dogs may arrive at any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

**Judges are not required to wait for dogs that are late.** Owners or agents alone are responsible for the presence of their dogs in the ring when their classes are called to be judged.

**All Dogs Present** must be on leash or crated except when being judged.

**All persons attending this event hereby waive** any claim for damages against Susque-Nango Kennel Club or its members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
