ENTRIES CLOSE at 6:00 PM, Wednesday, Oct.14, 2020 after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules. SEND ENTRIES WITH FEES TO Laura Trainor, 144 West Hill Rd., Vestal, NY 13850. MAKE CHECKS PAYABLE TO SNKC (add \$5 for international money orders). No overnights entries requiring signature will be accepted.

ENTRY FEES: \$30 for 1st Obedience entry, \$26 for 2nd Obedience entry of same dog, same day. Rally \$30 first entry \$26 second entry, and \$22. third class.

50¢ recording fee for the first entry and \$3.00 event service fee for both entries.

<u>ALL</u> Obedience and Rally Classes will be judged by jump height. Make sure your dog's jump height is on the entry. Classes will all be judged tall to small each day.

A RECORDING FEE will be required for each dog entered at any licensed or member club show. Obedience/Rally trial or Tracking test. This fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one Obedience class in the show, the recording fee is to be collected on the first entry only.

OWNERS ARE RESPONSIBLE FOR ERRORS in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.

TELEPHONE ENTRIES, UNSIGNED ENTRIES, and ENTRIES WITHOUT FEES will not be accepted. ENTRIES NOT ON AN OFFICIAL AKC ENTRY FORM or PHOTOCOPIES OF ENTRY FORMS WITHOUT THE

CONSULT JUDGING PROGRAM Dogs will not be permitted in the building until just prior to their class being judged. Please refer to detailed instructions which will be sent in the Entry Conformation document. Dogs not required for further judging are excused.

AMERICAN KENNEL CLUB CERTIFICATION Permission has been given by the

JUDGES WILL NOT WAIT for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The trial-giving club and the Secretary have no obligation or responsibility for providing service through a public address system, stewards or runners for the purpose of calling or locating dogs not brought into the ring when required.

DOGS MUST BE HELD ON LEASH or confined to crates except when being judged. EXHIBITORS MUST CLEAN UP AFTER THEIR DOGS at show site and motels.

ALL Obedience and Rally Classes will be judged by jump height. Make sure your dog's jump height is on the entry. All days will be judged tall to small. Judging will be indoors.

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3.(Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4.A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog had been acquired by a new owner it must be entered in the name of its new owner

in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
